October 2020 the calls had a significant decrease over last month with 204 total calls for service within the Town of High Level.

There were 7 reported assaults, 3 Assault with a weapon / causing bodily harm, 2 Aggravated Assaults, 1 Assault Police Officer file, 5 Criminal Harassment / Uttering Threats, and 1 Using a Firearm for intimidation. Charges have been laid on 12 of those files, 2 were unfounded, 1 still under investigation

There were 0 break and enter files reported in October.

There were 2 impaired driving complaints. Resulting in charges in 1 incident.

There were 26 Liquor Act related incidents. 2 resulted in charges being laid, the other 24 were lodged until they were sober and able to care for themselves.

There were 45 calls for mischief to property or obstruction of enjoyment of property which 43 were cleared using discretion and 2 were unfounded.

There were 7 mental health calls, 1 was unfounded and the other 6 files the persons were dealt via the hospital.

4 reports were received of missing person, all of which were located. There was 1 other report to locate a traveller from Yellowknife, NT, the traveller was located in the Red Earth Creek area.

There were 2 Firearm Related calls, 1 was unfounded and the other had insufficient grounds to proceed.

There were 3 Sexual Assault files, charges have been laid on file, 1 is still under investigation and 1 had insufficient evidence to proceed.

There were 6-911 calls, 4 of them were unfounded, and 2 were actual calls for service.

There was one bear call a few days before Halloween, members were able to contain it in one area and chase it back out of town to the East.

Other files included assistance to other agencies, accidents, and general assistance to the public.

High Level CRU executed a search warrant on a residence. 4 adults and 1 youth were arrested and charged with Possession for the purpose of trafficking cocaine

In early October Cst. Brian ORTMAN transferred to Morinville, AB. Cst. Paul STEWART arrived shortly after from Airdrie, AB and is a welcomed member to the Detachment. Cst. CHARLERY is presently off on Paternity Leave for a few months. Cst. PINARD had returned from his Paternity Leave in late September.

The new Seargent has yet to be named, it is now in the hands of the National Promotions Unit in Ottawa, we are hopeful to have the new Seargent named by Mid November.
