

March 2022 Report for the Town of High Level

March calls for service showed an increase from last month with 270 total reported calls within the Town of High Level.

There were 6 drug related investigations resulting in 2 charges being laid.

There were 17 total reported assaults; of these 11 were common assault, and 6 were an Assault with a Weapon or Causing Bodily Harm. Charges have been laid in 6 of those investigations.

There was 1 complaint of criminal harassment which is still under investigation. There were 5 complaints of uttering threats, with 2 cleared otherwise, 2 resulting in charges being laid and 1 deemed to be unfounded. There was also 1 complaint of uttering threats to property or an animal which remains under investigation.

There were 38 traffic related complaints, with 24 charges being laid. There were 4 charges for insurance coverage violations, and 1 charge for speeding, and 4 charges of driving while suspended. There were 16 other charges laid for various traffic offences. The remaining were cleared using officer discretion or are still under investigation.

There were 7 complaints of impaired drivers with 4 cleared using immediate roadside sanctions, 2 charges laid and the other was not located.

There were 8 traffic collisions resulting in property damage.

There were 29 Liquor Act related incidents, and 27 were cleared with officer discretion and the subjects were lodged until they were sober and able to care for themselves.

There were 43 calls for mischief/damage to property or obstruction of enjoyment of property resulting in 1 charges being laid, and the rest were cleared using officer discretion.

There were 6 firearm related investigations which all led to charges being laid.

There were 6 reported thefts under \$5000 complaint resulting in 1 charge being laid, 2 determined to be unfounded, and 3 remain under investigation.

There were 2 complaints of Fraud which 1 are still under investigation and 1 deemed to be unfounded.


There was 1 complaint of a stolen truck which was later deemed as unfounded.

There were 4 complaints of break and enters to residences, with 3 charges laid and 1 cleared using officer discretion.

There were 3 reports of missing persons, all have been located. There were 18 well being checks/assistance to the General Public and 6 mental health calls where individuals were referred to or dealt with via the hospital mental health services.

There were 17 reported 911 calls which resulted in 2 charges of public mischief being laid.

There were 29 complaints of failing to comply with various court orders which resulted in 24 charges being laid and 1 cleared with officer discretion.
