



**TOWN OF HIGH LEVEL
BYLAW NO. 1016-20**

A BYLAW OF THE TOWN OF HIGH LEVEL, IN THE PROVINCE OF ALBERTA, TO ESTABLISH ALTERNATE METHODS FOR ADVERTISING STATUTORY NOTICES.

WHEREAS pursuant to section 606 of the Municipal Government Act, RSA 2000, Chapter M-26, as amended, a council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in a bylaw under section 606.1;

AND WHEREAS pursuant to section 606.1(1) of the Municipal Government Act, RSA 2000, Chapter M-26, as amended, a council may, by bylaw, provide for one or more methods, which may include electronic means, for advertising proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606;

AND WHEREAS Council is satisfied that the advertising method set out in this bylaw is likely to bring matters advertised by that method to the attention of substantially all residents in the area to which the bylaw, resolution or other thing relates or in which the meeting or hearing is to be held;

NOW THEREFORE the Council of the Town of High Level, in the Province of Alberta, duly assembled, enacts as follows:

Short Title

1. This Bylaw may be referred to as the Advertisement Bylaw or Public Notification Bylaw.

Advertising Method

2. Any notice required to be advertised under section 606 of the Municipal Government Act of a bylaw, resolution, meeting, public hearing or other thing may be given, in accordance with the timelines prescribed in section 606 by publishing detailed notices on the Town's website: www.highlevel.ca
3. The Town of High Level may also use one or more of the following methods to advertise or to advertise detailed notices or summaries of website notices:
 - (a) Newspaper(s)
 - (b) Town's official social media sites;

(c) Other methods as may be directed by Town policy.

4. The Town of High Level will provide hard copies of detailed notices available for viewing at the Town Administration Building.

This bylaw takes precedence over any other public notification process in any other bylaw or policy of the Town of High Level.

Effective Date

5. Bylaw 1016-20, being the *Advertisement – Public Notification Bylaw*, is passed and comes into full force and effect when it receives third reading and is signed by the Mayor and a designated officer.

READ a First time this 9th day of November 2020.

PUBLIC HEARING held on this 7th day of December 2020.

READ a Second time this 7th day of December 2020.

READ a Third time this 7th day of December 2020.
