

Ownership Restrictions

You can only possess a maximum of four (4) domestic animals **per household**. This does not include animals that are normally held in cages or aquariums.

No person shall keep, harbour, or have custody of any domestic dog or domestic cat within the boundaries of High Level without first registering their dog or cat with the Town of High Level. All dog or cat registrations shall permanently be associated with the same dog or cat.

Bylaw 1032-23, Sec.11 states:

Owners of more than four (4) Domestic Animals prior to the passing of this bylaw shall be permitted to continue harbouring more than four (4) existing Domestic Animals, but shall not replace the Domestic Animals if desired unless the number of Animals does not exceed the maximum limit of four (4).



Responsible Animal Ownership Bylaw

No. 1032-23

All dogs *and* cats must be registered with the Town of High Level and an annual registration fee must be paid for each animal every January, as per Schedule "H" of the Fees Bylaw.

If your dog or cat has a registered microchip or tattoo, you can provide the microchip information to the Town and will be exempt from the animal registration fees.

10 kg to 22 kg	\$20.00
23 kg or greater	\$40.00
Euthanization	\$250
After-Hours Call Out for Dog Control	\$100.00 + \$60.00 per hour per employee
